

INVESTOR Tokens



- Every OST business has its own UNIQUE investor token linked to it
- INVESTOR tokens are launched and promoted on our website/platform
- A limited number of tokens are made available based on the funding required
- Example: If we need 1 million dollars, we issue 1 million tokens at 1 dollar each
- Tokens make it easy for big and small investors to participate
- It becomes possible to **Crowd Fund our own businesses** in our communities and retain full ownership of them



One Small Town Is changing the world

INVESTOR Tokens - continued

- Each INVESTOR token collectively represents a 30% net profit share in that specific business
- The amount of net profit you receive, is relative to the number of INVESTOR tokens you hold
- Investors can take a up to a maximum of 30% holding in OST businesses
- 60% is always retained for the OST members of that community
- 10% is retained (4% to OST International, 6% to OST Country & Town)
- Tokens are stored in your OST digital wallet
- Token holders can send, share, or gift their tokens to anyone with an OST digital wallet
- Or token holders can place their tokens for sale on the OST Trading platform to a willing buyer
- In time there will be thousands of OST tokens to trade and share

We have created TWO types of OST Tokens



INFINITY: Is the OST asset-backed community reward token, earned by all members in all towns and countries



INVESTOR: Are used to raise funds for OST businesses based on the business plans we write



INFINITY Tokens

- Are used as proof of time contributed by members
- Members receive One token for every 3-hours contributed
- Tokens are deposited automatically into member's Digital Wallet in their OST membership account
- INFINITY token is an important means of exchange between members and will be our saving grace if the banking system should fail
- Tokens can be sent instantly and for free with your digital wallet, to any other OST member worldwide
- Tokens can be shared, or exchanged for items of value like food, car, etc.
- Tokens may be placed for sale on the OST Trading Platform to willing buyers
- Members can earn additional INFINITY tokens by contributing more time

Any town of 10,000 people has the capacity to turn over 1 Billion US dollars or more – per annum




With an expected gross profit margin of 60% (before costs) Two thirds of this belongs to the OST members
